1. TransPeshawar (hereinafter called "the Employer") is established by the Government of Khyber Pakhtunkhwa to operate the Bus Rapid Transit (BRT) system currently being implemented in Peshawar. Set up under section 42 of the company's ordinance, 2017, the Employer is responsible for BRT project design, procurement, implementation, on-going BRT operations and service contract management. The employer is committed to provide quality ridership services to citizen of Peshawar. Unique of its own kind in KP, Peshawar BRT will offer many unique features and facilities for daily future commuters of Peshawar.
2. BRT system will be served by 30 stations, and spans the entire urban region of Peshawar from Chamkani in the east and to Karkhano in the west. The BRT system is planned to be operating soon.

3. The Employer hereby requests for submission of Quotation for "**Renovation of TansPeshawar office at Chamkani**" as per attached **BoQ** hereinafter called "the Works"

If you, however, have been associated with the firm that prepared the requirements, and specifications of the contract that is subject of this procurement, you shall be disqualified.

4. It is understood that the bidder has gone through the entire Request for Quotation document and has complete understanding of the terms, conditions, specification/BOQ, and attached Form of Contract. The attached terms and conditions form an integral part of contract.
5. You must quote for complete scope of the Works under this request. Bidders not quoting for complete scope of the Works shall be disqualified.
6. A fixed lump sum total cost inclusive of all taxes shall be quoted in the Form of Quotation. Price quotations will be evaluated for all the items together and contract awarded to substantially responsive bidder offering lowest evaluated total cost of the Works.
7. You shall submit one Price Quotation on a Form of Quotation along with priced BOQ and supporting documents in accordance with para 9 below in a single envelope. Your quotation may be accompanied by adequate technical documentation and catalogue(s) and other printed material or pertinent information of the quoted items. The envelope shall be addressed to the Employer at the address provided below, bearing the name and address of bidder and title of the Contract.

8. Form of Quotation must be typed or written in indelible ink and shall be signed by you or your authorized representative. Without a signature on Form of Quotation, your quotation will be rejected as non-responsive.

9. Technical Criteria:

It is a fail/pass criterion. The bidders must fulfill all the requirements mentioned below.



- i. Registered with relevant legal/professional body; (Attach certificate of registration)
- ii. Registered with FBR and on Active Tax Payer List (ATL) of FBR; (Attach certificate of registration)
- iii. Registered with Khyber Pakhtunkhwa Provincial Revenue Authority in sale tax on services; (Attach certificate of registration)
- iv. Successfully completed/on-going at least two (02) similar contracts, each valuing PKR five (05) Million or more; (Attach work order/contract agreements/completion certificates)
- v. Minimum average annual turnover for last three (03) years is PKR ten (10) Million or more; (Submit financial statements of last three years)
- vi. An affidavit on stamp paper to the effect that the firm has not been blacklisted by any Federal or Provincial Public Entity;
- vii. Bid Security in accordance with Para 12 (vi) of RFQ;

Submission of supporting documents to the above requirements is mandatory. Failing to submit any of the above document shall result in non-responsiveness of the bidder.

10. Your quotation shall be submitted as per following instructions and in accordance with attached Form of Contract. The attached Terms and Conditions is an integral part of the Contract.

- (i) **PRICES:** - The unit rate and the prices to be quoted by the bidder shall be in Pak Rupees. The bidder shall fill in rates and prices for all items of the Works described in Bill of Quantities. Items against which no rate or prices is entered by the bidder will not be paid for by the Employer when the contract is executed and shall be deemed to be covered by rates and prices for other items in the Bill of Quantities. All duties, taxes and other levies payable by the Contractor under the Contract shall be included in the rates and prices and the total Bid Price submitted by the bidder. The total sum (Bid Price) in BoQ shall be carried forward to the Form of Quotation. The rates and prices are fixed and are not subject to change during currency of the contract.

In evaluating the quotations, the Employer will adjust for any arithmetical errors as follows:

- where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
- where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern;



- (ii) **EVALUATION OF QUOTATIONS:** Offers having no reservations to the terms and conditions, and meeting the requirements regarding scope of the Works, specifications and documentation mentioned under paragraph 9 above shall be declared as substantially responsive. The Employer shall evaluate and compare the prices of only those quotations determined to be substantially responsive
- (iii) **AWARD OF CONTRACT:** The contract will be awarded to the bidder having lowest evaluated bid price against given specification and determined substantially responsive. The bidder whose quotation has been accepted will be notified of the award of contract within validity period through Letter of Acceptance issued by the Employer. The contract may be offered to next substantially responsive, lowest bidder if the first lowest bidder repudiates the contract.
- (iv) **VALIDITY OF THE OFFER:** Your quotation should be valid for a period of ninety (90) days from the deadline for receipt of quotation indicated above.
- (v) **COMMUNICATION:** Bidders should note that during the period from the receipt of the quotation until award of Contract, all queries should be communicated in writing via e-mail below.

(vi) BID SECURITY:

- (a) Bid security shall be submitted to the amount of PKR one hundred and fifty thousand (PKR. 150,000) in shape of Demand Draft/CDR/PO from scheduled bank of Pakistan in the name of Chief Executive Officer (CEO) TransPeshawar. A bid not accompanied by compliant bid security shall be rejected as non-responsive;
- (b) The requisite bid security shall remain valid for a period of Twenty-Eight (28) days beyond the original period of bids validity;
- (c) Bid security of the unsuccessful bidders shall be released once the successful bidder furnishes the prescribed performance security or on the expiry of validity of Bid Security whichever is earlier.
- (d) The bid security of successful bidder shall be returned once the successful bidder has signed the contract and furnished the required performance security.
- (e) The Bid security shall be forfeited:
 - If a bidder withdraws his bid during the period of bid validity; or
 - If a bidder doesn't accept the correction of his Bid Price, pursuant to Para 10 (i) above; or
- (f) In the case of a successful bidder, if he fails to:
 - Furnish the performance security in accordance with Para 10 (viii) below;
 - Sign the contract agreement, in accordance with Para 10 (vii) below.



(vii) Signing of Contract

- (a) Promptly after issuance of Letter of Acceptance, the Employer shall send the successful Bidder the Form of Contract.
- (b) Within fourteen (14) days of receipt of the Form of Contract, the successful Bidder shall sign, date, and return it to the Employer.

(viii) Performance Security

- (a) Within Fourteen (14) days of the receipt of Letter of Acceptance from the Employer, the successful Bidder shall furnish the performance security in accordance with the Conditions of Contract;
- (b) Failure of the successful Bidder to submit the above-mentioned performance security or to sign the Contract Agreement shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security;
- (c) Performance security shall remain valid throughout the execution of contract and shall be returned within 10 days after the expiry of defect liability period and subject to satisfactory performance under the contract;
- (d) The Performance security may be forfeited if the contractor failed to deliver in accordance with the terms and conditions of the contract or commits any breach of the Contract or unable to correct the defects during defect liability period.

11. This Request for Quotation is being conducted under ADB Procurement Guidelines. As such under ADB's Anti-Corruption Policy, bidders shall observe the highest standard of ethics during the procurement and execution of such contracts. ADB will reject a proposal for award, and will

impose sanctions on parties involved, if it determines that the bidder recommended for award or any other party, has engaged in corrupt, fraudulent, collusive, or coercive practices in competing for, or in executing, the Contract. At the time of submission of your quotation, you should not be in ADB's sanctions list.

3. TERMS AND CONDITIONS

Name of Contract: Renovation of TransPeshawar Office at Chamkani

Contract Number: TPC/A&HR/W/Shopping/2020/001/RB

Completion Period: Six (06) weeks from date of signing of the contract.

1. The Contractor hereby covenants to execute the works fully described in the Bill of Quantities included in the Contractor's Quotation (attached as Annex-1) which constitute an integral part of this Contract in a professional and workmanship like manner in accordance with the following Conditions of Contract:
 - (a) Prices contained in the Form of Quotation shall remain firm and fix and not subject to any adjustment during currency of the contract.
 - (b) Upon delivery of goods, the Supplier shall provide the following documents to the Purchaser:
 - (i) Manufacturer's warranty certificate (where applicable); and
 - (ii) Certificate of origin/Purchase invoice (where applicable).
 - (c) The Contractor shall confirm compliance with the specifications mentioned in the BoQ.
 - (d) The Contractor remedy all defects without any cost to Employer within 07 days of notification by the Engineer in charge to be notified by the Employer during the period of execution of the contract and thereafter defects notified within the defect liability period;
 - (e) The Employer reserves the right to terminate the contract due to unsatisfactory performance within 10 working days after giving a written notice;
 - (f) If the Contract is frustrated by the outbreak of war or by any other event entirely outside the control of either the Employer or the Contractor, the Engineer in charge shall certify that the contract has been frustrated. In such an event, both the Employer and Contractor will have a right to terminate the contract by giving 10 working days' notice to the other party without any financial repercussions on either side;
 - (g) Payments after termination or frustration shall consider the value of work completed and materials delivered by the Contractor;
 - (h) All material on site, temporary works, and Works shall be deemed to be the property of the Employer if the contract is terminated due to fault of the Contractor;
 - (i) The Contractor will in all cases abide by the directions of the Engineer in charge;
 - (j) The Contractor shall submit to the Engineer in charge, a program within 05 working days after signing the contract describing general methods and schedule to complete the works;
 - (k) No part of the works shall be subcontracted without prior approval of the Employer;
 - (l) New items of work performed as ordered by the Engineer in charge will be paid at the mutually agreed rate and in case of any disagreement between the Contractor and the Engineer in charge, the latter will fix the unit rate(s) that will be binding on the Contractor;
 - (m) The Law governing the contract shall be applicable laws of Islamic Republic of Pakistan;
 - (n) The Contractor shall be responsible for the safety of all the activities and any damages to the existing infrastructure on the Site. Contractor shall be responsible for the repair of any damage(s) caused during execution of the contract and bringing it back the condition before damage to the satisfaction of Engineer in charge.
 - (o) During execution of work(s), the Engineer in charge will carry out inspection of work(s)/goods at site to verify that work(s)/goods are executed by the Contractor in


- accordance with the required specifications and finishing according to the satisfaction of Engineer in charge. Engineer in charge will reject works/goods not performed/delivered in accordance with required workmanship/specifications and the Contractor shall take immediate actions to rectify all defects within defect liability period;
- (p) Either party may terminate the Contract by giving a 10 working days' notice to the other for unforeseen events such as wars and acts of Gods such as earthquake, floods fires etc. In such case the payments will be made to the date of termination of contract;
 - (q) The Contractor is responsible for all taxes, duties, levies, etc. in accordance with the laws of the Islamic Republic of Pakistan; and
 - (r) The disputes between the Employer and the Contractor arising between them under or in connection with the Contract shall be resolved amicably. In the event the dispute remains unresolved between the Employer and the Contractor, the dispute shall be settled in accordance with the provision of the Arbitration Act 1940 of Pakistan.
2. In consideration thereof the Employer covenants to pay the Contractor the contract price of PKR- ----- (in words and figures) in the following manner and installments:
- (i) Each installment payment will be due for payment within 21 days of submission of invoice subject to affirmative determination of quality/quantity of goods/works by the Engineer in charge when the value of the work actually performed, calculated on the basis of unit prices and quantities, reaches 25 percent of the contract amount.
 - (ii) The Contractor shall submit manually signed Invoice mentioning that the actual work done against the BoQ;
 - (iii) The final payment of 20 percent of the contract amount shall be made upon completion of the works certified by the Engineer in Charge.
3. The defect liability period will be (06) months after taking over of all completed work under the Contract by the Employer;
4. Performance security shall be Ten (10%) of the Contract Price in PKR in shape of CDR/DD or Bank Guarantee, at the option of bidder, in the name of CEO TransPeshawar from schedule bank of Pakistan and shall be provided not later than the date specified in the Letter of Acceptance. Extension of performance security shall be subject to extension of the Contract. The performance security shall be retained during performance of the contract and shall be released after expiry of defect liability period subject to satisfactory performance. Performance security shall be deducted if the Contractor defaults under the Contract;
5. Liquidated damages of one tenth of one percent (0.1%) for each day of delay in completion of the Works may be deducted subject to a maximum of 10% of the Contract Price;
6. All Electrical and Multi-Media Appliances/Goods provided by the Contractor under the Contract shall be covered by manufacturer's warranty for at least 12 months from the date of delivery to the Employer;
7. The contractor shall provide manufacturer's or supplier's warranty certificate and certificate of origin/purchase invoice with the delivered goods.
