- 1. The TransPeshawar (hereinafter termed as "Employer") established by the Government of Khyber Pakhtunkhwa under Companies Act 2017, hereby requests quotations from firms/company/contractors (individuals) for "Provision and Installation of Security Gates and Portable Security Guard Cabins at Peshawar BRT Corridor" to prevent illegal entry of vehicles and humans into BRT system. The firm/company must be
 - i. Registered with SECP or Registrar of Firms (attach certificate in case of a Firm/Company);
 - ii. Registered with PEC in category C6 or above (attach certificate);
 - iii. Registered with FBR and reflected on the active tax payer list (attach evidence);
 - iv. Registered with KPRA for sales tax on services (attach evidence);
 - v. Experience of at least five years in civil related works with reputed Govt/Private entities (Attach a client's certificate of completion or work order).

If you, however, have been associated with the firm that prepared the design, specifications, or engaged in the preparation of the Project or firm that will provide supervision of the Works, you shall be disqualified.

To assist in the preparation of your price quotation, the necessary specifications, bill of quantities and drawings, form for submitting the quotation and a draft contract form are enclosed. You are advised to visit the site of the works at your own expense, and obtain necessary information for preparing your quotation.

- 2. You shall submit one original of the Price Quotation with the Form of Quotation, and clearly marked "Original". In addition, you will also submit one copy marked as "COPY".
- 3. Your quotation in the attached format should be signed, sealed in an envelope and addressed to and delivered at the following address:

- 4. You must have experience of at least five years in civil related works with reputed Govt/Private entities and evidenced by a client's certificate of completion or work order otherwise you not be considered further.
- 5. You shall submit only one quotation. Your quotation must be typed or written in indelible ink and shall be signed by you or your authorized representative. Without a signature in your Form of Quotation, your quotation will not be considered further.
- 6. In evaluating the quotations, the Employer will adjust for any arithmetical errors as follows:
 - (a) where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
 - (b) where is a discrepancy between the total price in the Bill of Quantities or the quoted amount indicated in the Form of Quotation, the total price in the Bill of Quantities shall govern;
 - (c) where is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern; and

- (d) if you refuse to accept the correction, your quotation will be rejected.
- 7. Your quotation shall be valid for a period of thirty (30) days from August 24, 2020.
- 8. Your quotation in duplicate and written in English language shall be for the whole works and based on the *unit and total price indicated in the filled-in Bill of Quantities*". Currency of quoted prices and payment shall in Pak Rupees. The quotation shall include all duties, and taxes and other levies payable by the contractor in accordance with local laws. In case of any discrepancy between the original and copy, the original shall prevail.
- 9. The Employer will award the contract to the Contractor whose quotation has been determined to be substantially responsive to this Request for Quotation and who has offered the lowest evaluated price quotation. A quotation is not substantially responsive if it contains material deviations or reservations to the terms, conditions, and specifications in this Request for Quotation, and it will not be considered further. The Employer will evaluate and compare only the quotations determined to be substantially responsive.
- 10. If you withdraw your quotation during the validity period and/or refuse to accept the award of a contract when and if awarded, then you will be excluded from the list of contractors for the project for two years.
- 11. The contract will be governed by the terms and conditions of the attached Form of Contract.
- 12. Your quotation including Form of Quotation and filled-in "Bill of Quantities" should be submitted by 03:00 PM (PST), August 24, 2020. The quotations shall be opened in public in presence of contractors' representatives who choose to attend on August 24, 2020 at 03:15 PM (PST) the following address:



- 14. The Employer intends to apply funds from the Asian Development Bank (ADB) for eligible payments under the Contract resulting from this RFQ
- 15. Under ADB's Anticorruption Policy bidders shall observe the highest standard of ethics during the procurement and execution of such contracts. ADB will reject a proposal for award, and will impose sanctions on parties involved, if it determines that the bidder recommended for award or any other party, has engaged in corrupt, fraudulent, collusive, or coercive practices in competing for, or in executing, the Contract. At the time of submission of your quotation, you should not be in ADB's sanctions list.
- 16. Please Confirm by fax/e-mail the receipt of this request and whether or not you will submit the price quotation(s).

SECTION 1 SPECIFICATIONS & DRAWINGS

- 1. The firm/company shall supply and install Security Gates and Portable Security Guard Cabins at BRT Corridor as per given specifications and drawings.
- 2. The Gates and Cabins shall be supplied and installed at locations mentioned in section 2 "Bill of Quantities" below. These installation points must require TransPeshawar prior approval.
- 3. The Security Gates and Cabins must have functional requirement / specification as follows;
 - There are two types of Security Gates, Sliding and Swing/door Gate, and Potable security Guard Cabins. Bollards are to secure the sliding gates at proper location to restrict the entry and exit of unwanted vehicles;
 - b) Sliding gates are provided at BS-00 and Pishtakhara round about on souths ring road where the surface is plan and have space for sliding;
 - c) Bollards at each end to secure the gate at fixed location will be approved by Employer;
 - d) Swing type gates are provided at Mix traffic ramp at Chamkani depot from Nowshera side and one at BS-00 Ramp. Hing mechanism at concrete barrier side and locking mechanism will be proposed by the contractor for approval;
 - e) The Gates are Mild steel locally available;
 - f) Cabins shall be made from Mild steel and GI sheet as the outer shell. The frame shall be strong enough to with stand the intended load and can be lifted without any damage for moving from one location to another.
 - g) The inner side is made insulated material with MDF to prevent heat during harsh weathers. The cabin shall be proper sealed to prevent the ingress of rain and washing water inside which may damage thermopore and MDF.
 - h) The windows arrangement is shown in drawings. Front and opposite to door windows shall be sliding and the other two fixed. The floor Plate shall be checker plate of the desired thickness.
 - i) All the mild steel shall be rust protected with red oxide with recommended number of coats;
 - j) Paint color will be approved by employer.







Bollard:

Note:

- Make a 6" dia core in concrete to a depth of 12" or as per site condition in Paved surface
- 2 Inser 4" G.I Pipe (Light) 5' Long.
- 3 The Pipe should project as per direction of engineer
- 4 Insert the Pipe in hole and fill the surrounding with fine concrete, Properly compacted
- Fill the pipe with fine concrete properly compact by roding and make the top dome type as shown in drawing
- 6 The pipe top edges must be grinded to smoothen for smooth touch.






Notes: 1.0 Hinge Mechanism to Concrete barrier shall be provided with the approval of Engineer incharge.

- 2.0 Contractor need to provide industrial grade Locking Mechanism between both doors
- 3.0 The Bottom Chord slope will be based on Slope of road, may vary from 1 ft to 2 ft
- 4.0 Payment will be made on Measurement shown above "Cost = PKR/meter"

Portable Security Guard Cabins

- 1 Providing and fixing of Portable Security Guard Cabin, Made of Mild steel frame with 20 SWG GI sheet outer facing.
- 2 18 mm thick single side laminated MDF will be nailed/pasted to wooden frame max 2' x 2' (wall and roof) inner side of GI sheet made of 1"x2" thick partal wood, complete in all respect
- 3 approximately 2" thick thermopore insulation sheet will be sandwiched between GI sheet and MDF between wooden frame
- 4 The above arrangement also applies to Door construction. Standard size door will be provided with all necessary industrial standard accessories
- 5 14 SWG Steel floor plate supported by enough mild steel sections.
- 6 The window height from 3'-6" to 6'-0" (2'-6") from the top of the floor.
- 7 All Glass Widows shall be provided with safety grill as approved.
- 8 Sliding glass windows need have locking arrangement from inside
- 9 Rust treatment (Red Oxide) of mild steel and Painting of cabin as per engineer approval

- 11 The steel structure need to be sealed from all side so that water shall not penetrate in the joints.
- 12 The Structure shall have 4" heigh strong supports from the bottom to provide enough clearance underneath. Electrical

Lights: One inside point with Chinese LED bulb and one out side point in front with Chinese LED bulb.

Socket: One universal socket in side

Fan: One bracket fan mounted on wall opposite to door

Power: Power supply cable from nearest corridor light pole with energization.

TERMS AND CONDITIONS

Project Name Provision and Installation of Security Gates and Portable Security Guard Cabins

Employer TransPeshawar (The Urban Mobility Company)

1. The Contractor hereby covenants to execute the works fully described in the Bill of Quantities included in the Contractor's Quotation which constitute an integral part of this Contract in a professional and workmanship like manner in accordance with the following Conditions of Contract:

- a. Remedy all defects within seven (07) days of notification by the Engineer in charge during the period of execution of the contract and thereafter defects notified within the defect liability period;
- b. The Employer reserves the right to terminate the contract due to unsatisfactory performance within ten (10) working days after giving a written notice. If the Contract is frustrated by the outbreak of war or by any other event entirely outside the control of either the Employer or the Contractor, the Engineer in charge shall certify that the contract has been frustrated. In such an event, both the Employer and Contractor will have a right to terminate the contract by giving ten (10) days' notice to the other party without any financial repercussions on either side. Payments after termination or frustration shall consider the value of work completed and materials delivered by the Contractor, and the advance payment made by Employer;
- c. All material and construction equipment on site, temporary works, and Works shall be deemed to be the property of the Employer if the contract is terminated due to fault of the Contractor;
- d. The Contractor will in all cases abide by the directions of the Engineer in charge;
- e. The Contractor shall submit to the Engineer in charge, a program within five (05) working days after signing the contract describing general methods and schedule to complete the works;
- f. Contract completion period is Sixty (60) days after signing of the contract;
- g. No part of the works shall be subcontracted without prior approval of the Employer;
- h. New items of work performed as ordered by the Engineer in charge will be paid at the mutually agreed rate and in case of any disagreement between the Contractor and the Engineer in charge, the latter will fix the unit rate(s) that will be binding on the Contractor;
- i. The Law governing the contract shall be applicable laws of Islamic Republic of Pakistan;
- j. The Contractor shall be responsible for the safety of all the activities and any damages to the existing infrastructure on the Site. Contractor shall be responsible for the repair of any damage(s) caused during execution of the contract and bringing it back the condition before damage to the satisfaction of Engineer in charge;
- k. During execution of work(s), the Engineer in charge, ------ (name) will carry out inspection of works at site to verify that works are executed by the Contractor in accordance with the required specifications and finishing according to the satisfaction of Engineer in charge. Engineer in charge will reject works not performed to the required specifications and the Contractor shall take immediate actions to rectify all defects in accordance with paragraph (a) above;
- Either party may terminate the Contract by giving a 10 working days' notice to the other for unforeseen events such as wars and acts of Gods such as earthquake, floods fires etc. In such case the payments will be made to the date of termination of contract;
- m. The Contractor is responsible for all taxes, duties. levies, etc. in accordance with the laws of the Islamic Republic of Pakistan; and

- n. The disputes between the Employer and the Contractor arising between them under or in connection with the Contract shall be resolved amicably. In the event the dispute remains unresolved between Employer and the Contractor, the dispute shall be settled in accordance with the provision of the Arbitration Act 1940 of Pakistan;
- 2. In consideration thereof the Employer covenants to pay the Contractor the contract price of ------ (in words and figures) in the following manner and installments:
 - i. Payment shall be made in four (04) equal installments. All installment payments will be made at the rate of 25 percent of the contract amount. Each installment payment will be due for payment within ten (10) days of submission of invoice when the value of the work actually performed, calculated on the basis of unit prices and quantities, reaches 25 percent of the contract amount:

Payments shall be made to the Contractor within 10 days of the date of the payment request submitted by the contractor has been certified by the Engineer in Charge.

3. The defect liability period will be 12 months after taking over of all completed work by the Employer.
