“PROCUREMENT OF PURE-ELECTRIC BUSES (12 METER BUSES) FOR BRT PESHAWAR SYSTEM”

TransPeshawar (The Urban Mobility Company) is a Govt. owned Company set up under Section 42 of the Companies Act, 2017 and is responsible for project implementation, management, operations and maintenance of urban rapid transit projects assigned by the Khyber Pakhtunkhwa Urban Mobility Authority (KPUMA).

TransPeshawar intends to procure pure electric buses for public transport operations in Peshawar, Khyber Pakhtunkhwa Pakistan. In this regard, TransPeshawar seeks applications from eligible Original Equipment Manufacturer (OEM) to participate in the **PRE-QUALIFICATION PROCESS** for the provision of pure electric buses as per the details mentioned in the pre-qualification document.

Terms & Conditions:

1. Pre-Qualification Documents (PQD) may be downloaded by the interested applicants from the websites of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (<https://www.kppra.gov.pk>), EPADS (<https://kp.eprocure.gov.pk/>) and TransPeshawar (<https://transpeshawar.pk>) from publishing of this notice in newspaper till last day for submission of applications.
2. Applicants meeting the basic eligibility requirements as stated in the PQD shall be eligible to participate.
3. Applications shall be submitted electronically through EPADS. The hard copy of applications shall not be entertained.
4. Interested OEMs are requested to register online on the KPPRA Portal: e-Pak Acquisition & Disposal System (EPADS) (<https://kp.eprocure.gov.pk>) for submission of application. For registration and guidance on EPADS, the applicants may contact KPPRA at +92-91-9213433/+92-91-9213437.
5. The Applicants shall be required to submit a non-refundable fee of PKR 50,000 (Pak Rupees Fifty Thousand Only) or USD 200 (United States Dollars Two Hundred Only) by Pay Order/ Demand Draft in favour of “CEO TRANSPESHAWAR” as PQD fee. Pay order/Demand Draft in hard shall be submitted to the undersigned on or before deadline for submission of applications.
6. A clarification meeting will be held at the office of the undersigned on **January 21, 2026, 1130 hours (PST)** for applicants who choose to attend.
7. The applications complete in all respect as per requirement of Pre-qualification Document (PQD) shall be submitted thorough EPADS on or before **February 13, 2026 at 1100 hours (PST)**.
8. The application shall be opened on same day, **February 13, 2026, at 1130 hours (PST)** through EPADS at the office of undersigned in the presence of applicants who choose to attend.
9. Only Prequalified applicants shall be invited for submission of technical and financial bids in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority procurement law and the rules made thereunder.
10. TransPeshawar reserves the right to reject any or all Applications at any time prior to the acceptance of application. TransPeshawar, upon request will communicate to any applicant who submitted an application, the grounds for its rejection of application.
